This thesis delves into the concept of "conscience" in the context of social sciences, aiming to introduce and theorize a geographical approach to human conscience. The objective of this thesis is the introduction of the first integrated geographical, "more-than-anthropocentric" approach to the study of human conscience, to which the factor of "space" is argued to be of paramount significance. The application of the study of conscience to spatial matters is expressed by the term "spatial conscience"; it is determined by all sorts of human-space interrelations and interactions and shaped through human perception, emotion and behaviour. The thesis further proceeds to the application of the geographical approach to conscience through the landscape, as the most appropriate spatial unit for the analysis of conscience, and develops a model of 'landscape conscience' that pulls together human perceptions, emotions and behaviours deriving from, expressed through and affecting human-space interrelationships. This 'model of spatial conscience' is intended as a conceptual and analytical tool in the assessment, development and improvement of human spatial/ landscape conscience, in the context of landscape planning, research, education, policy formulation and implementation through public participation, etc. The particular landscape conscience model aims at the advancement of landscape theory and furthermore, it specifically purports to contribute to a broader and more effective and in-depth application of the European Landscape Convention (ELC) among European countries that lag in this respect. In fact, such an understanding, analysis and interpretation of human-landscape interactions on the basis of landscape conscience is essential and imperative if public participation and governance are to be engaged in landscape conservation, management and planning (in the context of ELC aims at more balanced human-landscape interrelations and a higher quality of life). The model is applied in the Greek countryside, and specifically on the island of Lesvos Island and in the region of Arcadia.

  - Series of publications in local press, planning and processing and of posters/leaflets, etc, regarding prospects of insular development, rural change, landscape management and planning, alternatives sources of tourism, sustainable development, etc.
  - Series of announcements in local meetings, conferences, regarding local development, enterpeneurial dynamics, landscape, ecomuseums, etc.
  - Participation in various citizens' acts regarding the environment, society, civil protection, self-government, social economy and culture (Environmental-Cultural Society of Pamfila, aeolistas, SCE Modousa, SCE Ifestio Anemotias, SCE Parea at Lesvos, Initiative of Active Citizens of Lesvos).
